### Company Culture

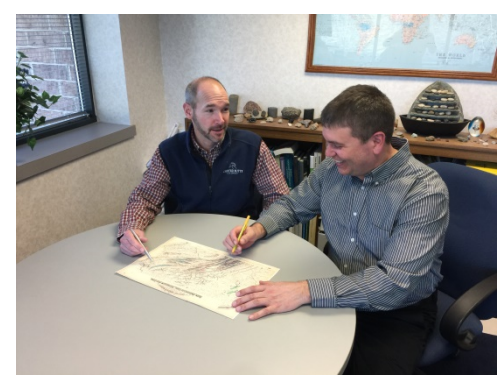
